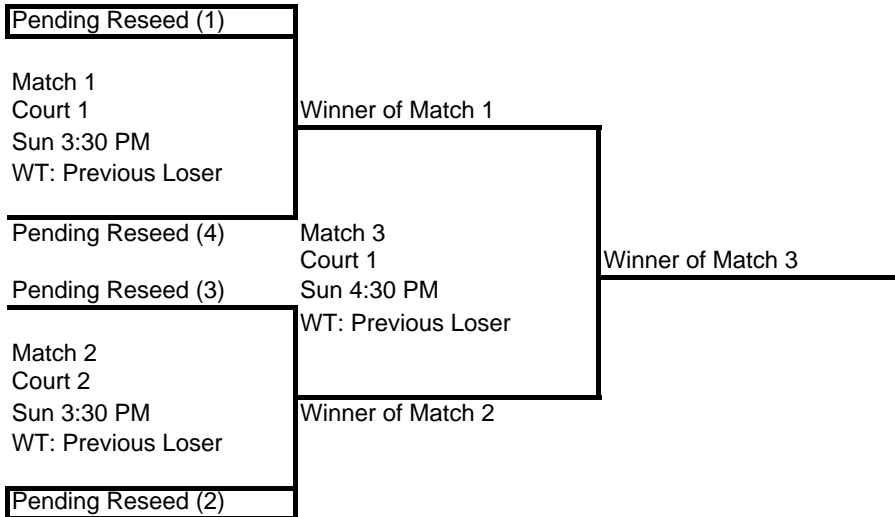
**Tournament Notes**

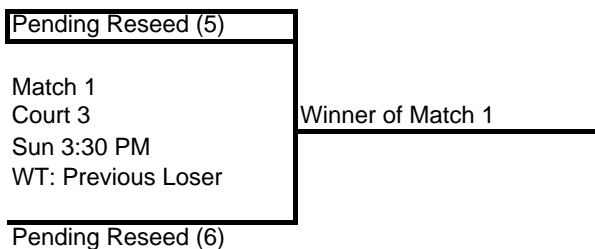

## TOURNAMENT RULES & PROCEDURES

### Schedule

Please consult the schedule carefully to observe match times and officiating duties.

Officiating teams be especially aware of the first match start time.

We ask that those teams arrive at least 30 minutes prior to the posted match time.

### Rules of Play

All matches will be 2 out of 3 games to 25, no cap. Deciding game to 15, no cap.

Tie breaker if tied match record --> Game won/lost % --> Head-to-Head --> Point Differential (Great Lakes Region Procedure)

### Officiating Duties

We will supply 1st (up) officials for all pool play matches. The officials are either officials for all pool play matches. The officials are either club coaches or experienced 18 & Under players.

Teams will be responsible to provide R2 (down officials), line judges, scorekeepers, and libero trackers.

USAV officials will be assigned for the semi-finals and finals of the Gold Division Bracket.

### Warm-up

Warm-ups for the first two rounds of the day will be 5 - 4 - 4 (Shared Court - Full Court - Full Court)

Warm-ups the remainder of the day will be 2 - 4 - 4 (Shared Court - Full Court - Full Court)
